1. We act for and on behalf of a group of individuals known as Save EOH (“**Save EOH**”), which constitutes a group of erstwhile employees and shareholders, and other interested parties of EOH Holdings (“**EOH**”).
2. Our instructions are to withhold the identity of the members of Save EOH for several reasons, due to, inter alia, the fear of targeted harassment of such members, and other related security issues.
3. Save EOH is desirous of preventing the further demise of EOH, and of protecting the rights and continued employment of the remaining 5500 staff members employed by EOH Group, its shareholders, and other stakeholders, who have been prejudicially
